#### **HOME VISITING REPORT FY2021**

Compiled by the Illinois Early Childhood Asset Map (IECAM), this report is a joint effort of the major funders of home visiting in Illinois for the state Fiscal Year 2021 (July 1, 2020 through June 30, 2021). The tables and charts on the following pages summarize data for the following major public funders of home visiting:

- Illinois State Board of Education (ISBE) Prevention Initiative (PI). ISBE annually provides early
  childhood block grant (ECGB) funds to Chicago Public Schools, which then allocates funding to the
  Department of Family and Support Services (DFSS) for early care and education programming. Unless
  otherwise noted, the ISBE data includes data for Chicago programs.
- Early Head Start/Head Start Home-based (EHS/HS). For the purposes of this report, Head Start data has *not* been included. \*EHS is based on cumulative enrollment and includes the total number of children served *and* pregnant women. These data cannot be separated as (1) services for children and pregnant women are fully integrated and (2) separating the data would impact other data elements.
- Illinois Department of Human Services (IDHS) Healthy Families Illinois (HFI; Healthy Families America HFA). \*\* The IDHS Bureau of Early Childhood Development's Healthy Families Illinois providers used the Cornerstone system for recordkeeping and reporting through mid FY21. There are concerns about the quality of data in Cornerstone in the years leading up to the Cornerstone system sunset. In FY20 and FY21, IDHS used an electronic survey to collect year-end data from HFI programs for this report. In FY22 and beyond, HFI programs will use the Visit Tracker data system.
- Maternal, Infant, and Early Childhood Home Visiting (MIECHV). (The Maternal, Infant, and Early Childhood Home Visiting Program supports pregnant people and parents with young children who live in communities that face greater risks and barriers to achieving positive maternal and child health outcomes. Families choose to participate in home visiting programs, and partner with health, social service, and child development professionals to set and achieve goals that improve their health and well-being. - **Start Early.** These programs include IDHS Parents Too Soon and any other publicly funded home visiting programs not already included in the above data sets.

This report also includes separate sections with data from the following:

- City of Chicago DFSS-funded home visiting programs. As described above, ISBE annually provides early childhood block grant (ECGB) funds to Chicago Public Schools, which then allocates funding to DFSS for early care and education programming, including home visiting.
- **Privately funded Nurse Family Partnership**® (NFP) home visiting programs. In recent years, there have been increased levels of private funding to support NFP programs in Illinois.

The home visiting system in Illinois is complex and diverse. Multiple funding streams and numerous state, federal, and model requirements have resulted in varying data collection policies and the use of several different data management systems across programs, models, and funders in Illinois. These variations make it difficult to aggregate home visiting data, and some numbers may have been estimated. When necessary, notes have been provided to provide clarity to the summarized data.

### **Summary of Select Elements**

**Funding.** Table 1 indicates a gradual increase in funding for home visiting programs across the state. Of interest is the funding for EHS, which saw a dramatic increase of 59%. In addition, there was a sharp drop in MIECHV funds allocated to Illinois between Grant FY18 to Grant FY19, which was not reflected until SFY21 due to the 2-year spend down period for each grant.

Children & Primary Caregivers Served. The total number of target children served (Table 3) decreased by 9.5%, approximately 2,200 children across the table. The age and race/ethnicity of the children served are presented in Tables 5 and 6. Respectively, the total number of primary caregivers served (Table 7) decreased by 7.8%. The age and race/ethnicity and the primary caregivers are presented in Tables 8 and 9, with educational attainment of primary caregivers shown in Table 10. This table indicates the number and percentage of caregivers with less than a high school diploma and those enrolled in a GED program or in high school at the time of enrollment. With both a decrease in the total number of target children served and primary caregivers served, the impact of shifting policy and service provision during the COVID-19 pandemic, as directed by the State of Illinois, should be considered.

**Home Visiting Models.** Funders distribute money to several home visiting programs that have adopted a variety of different models to serve their children. Parents as Teachers (42%) serves the highest percentage of children by home visits, with Baby TALK (23%) and EHS (20%) following (Table 4).

Each of these tables and charts includes data directly from each data source (e.g., IDHS, ISBE) for fiscal years 2015 through 2021 (unless otherwise noted). Notes are included to refer the reader to either introductory remarks or clarifying information about the data.






